#### **Minutes**

- 1. The meeting was opened by Bengt Almkvist
- 2. Minutes from board meeting Nov. 6<sup>th</sup> 2012 was approved.
- 3. Treasure report, Anetté Johansson.

It was decided that ESIN will pay the last invoice of 3250 Euros to AIP (in result 1750 Euros: 3250 Euro with the deduction of 2012 membership and service fee for France, that has not been paid vet.)

Membership Fee for 2013 of 250 Euro will be sent out early 2013 to all members.

4. INSULEAR meeting Nov. 29th. Report from John Walsh.

John reported from the meeting in Brussels which he attended.

Article 174 was addresses: It should be written into the framework and the funding programmes. **See attached report and PP-presentations** 

John communicated with the CMPR, who aim at pushing the island issues at every presidency.

5. ESIN working group 174. Report from meeting Nov. 19<sup>th</sup>, preparing MEP-meeting.

After discussing the meeting on Nov. 29<sup>th</sup>, it was decided that ESIN should try to set up two meetings (i.e. push the meeting in January with Intergroup 174 a few months):

- first a meeting with Irish EU presidency, Irish agricultural people, CMPR and ESIN representatives in Ireland
- Later on in spring 2013 a meeting with intergroup 174 and MEPs from the membership countries in Brussels.

We should build a case for the meetings: Agricultural programme has the highest priority. Where does the agricultural programme NOT work for us? - And what can be done?

Then fisheries, structural funding etc. General rural development is pressed from all sides budget wise.

Every ESIN member state should give examples where 174 would help, where state aid rules are not working but are requested.

John will look into the calendar for the Irish presidency activities: are there one or two activities we want to feed into – in Brussels or in Dublin?

- 6. <u>European Focus Group for environmental services, ERDP</u>
  Anna-Karin took part in network meetings in DG-AGRI. **See attached report.**
- 7. <u>Agricultural Advisory Group. Possible for ESIN to request a post of Observer.</u>
  Positive reactions ESIN aims at finding ways to participate in these meetings.
- 8. <u>SMILEGOV</u> "Enhancing effective implementation of sustainable energy action plans in European islands through reinforcement of smart multilevel governance".

Timetable: Alexis sent a new set of questions, that we need to look at now. The project will take off in April 2013. Bengt / Camille will answer SMILEGOV on Thursday 13<sup>th</sup> for the first coming set of questions.

**ACTION POINT:** ESIN should form clusters with members from France, Ireland, Italy, Finland, Estonia and Aaland. ESIN should identify all the island energy plans in existence in each membership country.

So: Each ESIN member must reflect on how in practical terms each member/ESIN can deliver this. Deadline is January 8<sup>th</sup> 2013 (next ESIN board meeting).

## Additional note from working group meeting held on Skype Dec. 13th

ESIN working group 174: Report from meeting Dec. 13<sup>th</sup>.

ESIIN will focus on two meetings in the winter/spring 2013:

1. It was decided that ESIN should first focus on establishing a meeting in cooperation with CMPR in Ireland early 2013 with the Irish EU presidency officials, agricultural politicians, Alyn Smith and others. This meeting shall have a main focus on Islands and the agricultural programme, CAP, and will raise the issues in regards to article174, especially regarding islands situation: A focus on islands, as a supplement to the exiting focus on mountains.

John has been in touch with the Irish Islands Division and the Irish minister with island responsibilities. John will get more knowledge about dates, possibilities etc. in a meeting next week. John will try to get a calendar of events in the Irish presidency.

2. We shall then postpone the meeting between ESIN and the Intergroup 174 and Alyn Smith to early spring 2013, after the meeting in Ireland.

It is important to build a case around a few very specific issues Suggestions are:

- Transport costs for island (farmers, businesses etc.)
- Severe depopulation
- Increase De Minimis for state aid to small islands

## Other:

Also John informed that there will be a follow-up meeting to the INSULEAR meeting held on Nov. 29<sup>th</sup> that John attended. This second meeting will take place in May 2013. ESIN should prepare a declaration/proposal for this meeting. We should ask to be on the agenda and make a presentation on ESIN.
