- (a) Concerning CLLD's on page 8, line 7, after "climate change": insert "small-scale societies such as islands".
- (b) Concerning CLLD's, page 8, line 14: insert ", islands" after "fisheries"
- (c) Concerning ITI's, page 8, line 20: insert "a cross-border community" after "strategy"
- (d) Concerning Public Administration, page 48, line 22: insert "or the regional units for administrative service to less favoured areas such as small islands" after "ministries"

The lesson ESIN should learn from this is that Island profiling should happen in all cases of regulation being made or changed. The article 174 should be elaborated and made known throughout Europe so that it will actually be applied.
